Employee Costs

Because our employees and their families are important to us, DUC has increased the employer paid contribution for employees who have dependents. For the 2023-2024 benefit year, DUC is paying 65% of the total cost for both Health Net and Kaiser plans covering Employee+1 or Employee+Family.



What's the Same?

Core Health Plans

There will be no changes to the plans and options available for the following benefits:

- Health Net and Kaiser Medical
- Guardian Dental
- Guardian Vision with VSP Network
- Legal Shield and ID Shield (while there are no changes to these plan types and options, there are rate changes you should be aware of. Login to Paycom to review.)

DUC will continue to offer five medical plan options with an employer-sponsored contribution towards your Health Savings Account (HSA) when you enroll in one of the High Deductible Health Plan options.

All current medical, dental, vision and Legal Shield and ID Shield elections will carryover to the new plan year if you do not indicate any changes.
