HSA can be changed throughout the year and changes are made through Paycom. Submitted changes in Paycom will reflect in the next pay period.

Do FSA funds rollover?

Yes. For the 2023 and 2024 FSA, you may rollover up to \$610. Rollover is not applicable to Dependent Care FSA.

What if I lost my FSA card, how do I get a new one?

Can employees enroll in HSA and FSA?

Employees can't enroll in both plans. For HSA, you would need to be enrolled in High Deductible plans.
