### Accumulation Period

The Accumulation Period for this plan is January 1 through December 31.

### Out-of-Pocket Maximums and Deductibles

For Services that apply to the Plan Out-of-Pocket Maximum, you will not pay any more Cost Share for the rest of the Accumulation Period once you have reached the amounts listed below.

For Services that are subject to the Plan Deductible or the Drug Deductible, you must pay Charges for covered Services you receive during the Accumulation Period until you reach the deductible amounts listed below. All payments you make toward your deductibles apply to the Plan Out-of-Pocket Maximum amounts listed below.

Routine physical maintenance exams, including well-woman exams ....	No charge (Plan Deductible doesn't apply)
Well-child preventive exams (through age 23 months) .....	No charge (Plan Deductible doesn't apply)
Routine eye exams with a Plan Optometrist .....	30% Coinsurance (Plan Deductible doesn't apply)
Urgent care consultations, evaluations, and treatment .....	30% Coinsurance after Plan Deductible

Most immunizations (including the vaccine) .....	No charge (Plan Deductible doesn't apply)
Most X-rays and laboratory tests .....	30% Coinsurance after Plan Deductible
Preventive X-rays, screenings, and laboratory tests as described in the <i>EOC</i> .....	No charge (Plan Deductible doesn't apply)

### Hospital Inpatient Services

Room and board, surgery, anesthesia, X-rays, laboratory tests, and drugs .....	<b>You Pay</b> 30% Coinsurance after Plan Deductible

Most brand-name items (Tier 2) at a Plan Pharmacy .....	\$35 for up to a 30-day supply after Plan Deductible
