

How to File a Life or Accidental Death Claim for Employers.



1 BEFORE YOU FILE A CLAIM

Our online intake platform will allow you to file claims involving death. Below are pieces of information you will need to provide as part of this process:

- › All beneficiary designations on file, policy, and coverage details as well as employment verification information
- › Assignments, court orders, or any other documents that may affect payment
- › A copy of the death certificate
- › Life insurance enrollment forms for voluntary benefit
- › For Accidental Death insurance claims, as well as some life insurance claims, we may ask for reports, such as a police or medical examiner report, if available.

2 FILING A NEW CLAIM OR CONTINUE AN EXISTING CLAIM

1. Go to www.nylgbslifeclaims.com/portal
2. Upon logging in, you'll be taken directly to your claims dashboard. From there, you can continue to file a new or complete a claim that is in process.
3. Read the state fraud warnings and accept.
4. For a new claim or one filed by the beneficiary, choose type: Life or Accidental Death Claim.
5. Complete all information that contains an asterisk (*).
6. Under **Death Claim** details choose whether the claim is for an employee, dependent spouse/partner, or dependent child.
7. Complete or verify the beneficiary information.
8. Upload documents relevant to the claim, review your claim, and submit.

3 CLAIM REVIEW AND APPROVALS

- › A Life claims specialist will be assigned. If they have any questions or need additional information, they will contact you or the beneficiary.
- › After we receive all requested information, a claim decision will be available within 10 business days.
- › If the claim is approved, we will notify you and send an approval communication to the beneficiary.
- › If the claim is denied, we will notify you and send the beneficiary a detailed communication explaining why the claim was denied and instructions on how to appeal the denial.
