

# 2025 HRA Benefit Summary Wente Family Estates Anthem Evolution Healthcare

#### **Plan Effective Dates**

January 1, 2025 - December 31, 2025.

#### **Benefits Provided**

Your Health Reimbursement Arrangement (HRA) is a benefit account established and funded by Wente Family Estates. Your HRA will reimburse you for service covered under your Anthem Evolution Healthcare group medical plan. While you may use your HRA to pay for covered services incurred inside or outside of the Anthem Evolution Healthcare network, please be advised that seeing contracted in-network providers will stretch your benefit dollars further and reduce your out-of-pocket expenses.

#### **Excluded Services**

Your HRA Plan specifically excludes coverage for any services not covered by the existing Anthem Evolution Healthcare group medical plan. Over-the-counter medications, dental services, and vision services are not eligible for payment by your HRA plan.

#### **Maximum Annual HRA Benefit**

Employee Only \$1,500.00 Family \$3,000.00

You are also eligible to earn bonus HRA dollars that accumulate on top of your HRA maximum annual benefit in the amounts of \$200.00 for an individual or \$400.00 for family coverage upon completion to the Wellness Incentive Program. Submit completed affidavit to WFE Human Resources.

At the end of the year, unused HRA dollars rollover up to a maximum account balance of \$3,000.00 for an individual and \$6,000.00 for family coverage. For new participants added to the plan during the year, funds are prorated based upon your eligibility month.

# Marin Benefits Debit MasterCard®

You will receive a benefits card linked to your HRA. You may use this card to pay for qualified Anthem Evolution Healthcare group medical plan expenses incurred by you or your eligible dependents. Please note the following for your benefits card:



- Your benefits card will arrive preloaded and preactivated.
- Your benefits card may be used for your eligible expenses at any qualified service provider that accepts MasterCard®.
- Your benefits card may be used at the pharmacy for prescription drug expenses and/or to pay for your mail order prescriptions. Over-the-counter medications are not a covered benefit even when prescribed by a physician.
- Your benefits card does not have a PIN and should be used just like a credit card. Select the credit option to sign your purchase receipt at the sales terminal. If prompted to provide a billing zipcode please use your home zipcode.
- Always save your receipts as you may be contacted to substantiate benefits card charges.

## **How to Submit an HRA Claim**

If for any reason you do not use your benefits card, you may submit a claim to be reimbursed from your HRA. Claims may be submitted securely online in the Member Portal or by submitting an HRA Claim Reimbursement Form. Get your HRA reimbursement faster when you enroll for Direct Deposit in the Member Portal or by submitting a Direct Deposit Form with your claim. All forms and instructions are available at <a href="mainbenefits.com/forms">marinbenefits.com/forms</a>. Claims must be filed within ninety (90) days of the end of the calendar year in which services are incurred to be eligible for reimbursement.

# **HRA Refunds**

If you have used your HRA or benefits card to pay for an expense that is later reimbursed or refunded by your provider, IRS regulations require you to pay the amount back to your HRA. Please contact Marin Benefits with any questions about how to return provider refunds back to your HRA.
